Atrium Restaurant Christmas 2024 Lucky Draw

Terms & Conditions

- This Lucky Draw is organized by Atrium Restaurant (the "promoter") under Holiday Inn Singapore Atrium and is exclusive to diners of Atrium Restaurant located at 317 Outram Road Singapore 169075. All persons registering or taking part in this Lucky Draw (the "Participants") agree to be bound by these Lucky Draw Terms and Conditions.
- 2. The Lucky Draw is open to all individual Singapore residents who are: (i) aged 18 and above as at the start of the Lucky Draw Period; and (ii) not prohibited in any manner by any person, entity, authority or law anywhere in the world from participating in this Lucky Draw or any similar Lucky Draws. Employees of the Promoter are not eligible to participate in the Lucky Draw.
- 3. By participating in the Lucky Draw, each Participant represents and warrants that he/she has met the eligibility criteria stated in these Lucky Draw Terms and Conditions.
- 4. The Lucky Draw is valid from 18 November 2024 to 1 January 2025 (both dates inclusive, the "Lucky Draw Period"). Multiple entries are allowed per Participant, on condition that each entry submitted corresponds to a separate receipt, and that each Participant is only entitled to one prize in this Contest;

(ii) Each Prize Winner will have their dining receipt at Atrium Restaurant reimbursed, up to S\$1,000 maximum.

(iii) All entries for the Lucky Draw should have the lucky draw slip attached to the dining receipt. Failure to do so will be deemed as an invalid entry.

(iv) The draw will be conducted on 6 January 2025 and winners will be notified through email by 10 January 2025.

- 5. Only entries that are considered as complete and correct by the Promoter will be eligible. Incomplete or illegible entries will be disqualified.
- 6. Participants shall participate in the Lucky Draw on his/her own account, and shall not submit entries or participate on behalf of other persons.
- 7. Participants shall ensure that they remain contactable at all times. If the Promoter fails to contact any winner for any reason whatsoever, it may at its discretion elect to determine another winner in accordance with the Lucky Draw mechanism.
- 8. The Promoter may, without notice and at any time, substitute any prize with a prize of similar value, as determined by the Promoter. To the extent not prohibited by law, all warranties and representations in connection with the prizes are expressly excluded. Winners shall collect their prizes in person or as per instructed by the Promoter, and shall comply with and be bound by all terms which the prizes may be subject to.
- 9. To collect their prizes, winners shall present their NRIC or passport personally as verification document. The reimbursement process and channel will be fully determined by the Promoter. The award of prizes will be subject to verification to the full satisfaction of the Promoter. Any Participants who do not comply with the Lucky Draw Terms and Conditions will be disgualified.
- 10. The Promoter may, at its sole discretion, modify the Lucky Draw Terms and Conditions, make prize substitutions or cancel this Lucky Draw, without prior notice to any person. The Promoter's decisions on all matters relating to this Lucky Draw will be final, binding and conclusive on all Participants, and no correspondence will be entertained.
- 11. Where prizes contain a specified validity period during which it should be utilized, no requests for extensions or replacements whatsoever will be entertained. Prizes which remain unclaimed by any winner for 30 days after the announcement and notification sent to winners shall be conclusively forfeited by such winner, and the forfeited prize will be dealt with at the Promoter's discretion in accordance with applicable laws.

- 12. The Promoter may disregard or disqualify any entry, participant or winner, in such manner as The Promoter deems fit, without giving notice or reason, and without any liability to any person. In particular, no participant shall, or procure another person to, (i) tamper with the operation of the Lucky Draw, (ii) participate in the Lucky Draw in any manner which may create any prejudice to or anomaly in the scoring system or operation of the Lucky Draw; and (iii) breach these Terms and Conditions or any other applicable law or regulation.
- 13. To extent permitted by law, the Promoter will not be responsible or liable for any loss, injury, death, claim or damage suffered by any person arising out of or in connection with the Lucky Draw and prizes. Participant and any person acting on his/her behalf shall indemnify the Promoter from any claims, losses, damages, costs or expenses incurred in connection therewith.
- 14. The Promoter may use all contact information and personal data provided by each Participant to conduct verification and other actions in connection with the Lucky Draw (including but not limited to those actions stated in these Lucky Draw Rules).
- 15. Participants shall grant permission to the Promoter and its agents to take and to have full and free use of video/photographs containing their image/likeness, in any media or form ("Materials"). These Materials may be used for marketing, publicity and promotional purposes by and for the Promoter. Participants are not entitled to remuneration, residuals, royalties or any other payment from Promoter in respect of the creation and use of their image/likeness and/or the Materials. Participants release, discharge, and hold harmless the Promoter and its agents, employees and officers from any and all claims, demands or causes of actions that they may hereafter have in connection with the Materials.
- 16. Intellectual Property Rights mean all patents, rights to inventions, copyright and neighbouring and related rights, trademarks and service marks, business names and domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off or unfair competition, rights in designs, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets) and all other intellectual property rights, in each case whether registered or unregistered, and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world. Each Participant agrees that all worldwide Intellectual Property Rights in any statement, works or content submitted, made or created by a Participant in connection with the Lucky Draw, including but not limited to any ideas and/or concepts, and any derivative works arising therefrom, are perpetually, unconditionally and absolutely assigned to, vested in, and owned by the Promoter (the "Assigned Rights"). The Promoter may use these statements/contents/works in any way it deems fit without compensation to any Participant and each Participant waives all rights (including moral rights) he/she may have in such statements/contents/works. Each Participant agrees to execute all documentation to ensure the above, where required by the Promoter. Each Participant warrants that: (a) it is the sole legal and beneficial owner of, and owns all the rights and interests in, the Assigned Rights, (b) it has not licensed or assigned any of the Assigned Rights other than under these Lucky Draw Rules; (c) the Assigned Rights are free from any security interest, option, mortgage, charge or lien; (d) he or she is unaware of any infringement or likely infringement of any of the Assigned Rights, (e) all the Assigned Rights are valid and subsisting and there are and have been no claims, challenges, disputes or proceedings, pending or threatened, in relation to the ownership, validity or use of any of the Assigned Rights; (f) so far as he or she is aware, exploitation of the Assigned Rights will not infringe the rights of any third party; (g) the statements/contents/works are his or her original work and have not been copied from any other source.

17. This Lucky Draw is governed by Singapore law, and each Participant shall submit to the exclusive jurisdiction of the Singapore courts.

18. Any trademarks, graphic symbols, logos or intellectual property contained in any materials used in connection with this Lucky Draw, in particular that relating to the prizes, are the property of their respective owners.
